SCHEDULE OF FEES:

Membership in the Red Wing Area Farmer's Market Association is required to sell at the Market, the annual fee is \$40, payable with this application.

Choose from the permit fee options below:

OPTION 1 _____ Seasonal – 7 days/week, \$500 paid in advance.

OPTION 2 _____ Weekdays in front of City Hall, 315 W 4th Street, \$10 per day. **Weekday permits must be purchased in the Red Wing City Hall (opens at 8 AM) Monday through Friday, prior to selling.** Vendors must display their receipt of payment at their booth during selling hours.

OPTION 3 _____ Saturday only. \$160 paid in advance, or \$10/Saturday, if you check this option and intend to pay by the week, fees will be collected by the on-site market manager. Note: Summer season includes access to winter market as well.

OPTION 4 _____ Winter Market only. \$20 membership paid in advance, and \$10/Saturday, if you check this option note the Winter Market starts first Saturday in November and runs every Saturday through December, going to alternating weeks in January and February, last market day is first Saturday in March. Held at Sargent's Nursery.
